THRC Management, LLC, ("Management") as General Partner of Holdings, has exclusive voting and investment power over the shares of Issuer's Common Stock held by Holdings, and therefore may be deemed to beneficially own such shares. Dan H. Wilks, as sole Management, together with his spouse, Staci Wilks, who shares the same household, may be deemed to exercise voting and investment power over the shares of Issuer's Common Stock directly owned by Holdings and therefore may be deemed to beneficially own such shares.

Wilks Brothers beneficially owns 1,950,152 shares of Common Stock, representing 0.81% of the Issuer's issued and outstanding Common Stock. Wilks Brothers, LLC is a manager-managed limited liability company, managed by Dan H. Wilks and Farris Wilks. Dan H.
